Due to the 2019-2020 outbreak of the novel Coronavirus, COVID-19, we are taking extra precautions with the intake of each client, health history review, as well as sanitation and disinfections practices. Please read and sign below.

Symptoms of COVID-19 include:

- Fever
- Fatigue
- Dry Cough
- Difficulty Breathing

____ I understand the above symptoms and affirm that I, as well as all household members, do not currently have, nor have experienced the symptoms listed above with in the last 14 days.

____ I affirm that I, as well as all household members, have not been diagnosed with COVID-19 within the last 30 days.

____ I affirm that I, as well as all household members, have not knowingly been exposed to anyone diagnosed with COVID-19 within the last 30 days.

____ I affirm that I, as well as all household members, have not traveled outside of the country, or to any city outside of our own that is or has been considered a “Hot Spot” for COVID-19 infections within the last 30 days.

____ I understand that this business and my Aesthetician cannot be held liable for any exposure to the virus or any other contagion caused by misinformation on this form or the health history provided by each client.

____ I understand that, esthetic services involve maintained touch and close physical proximity over an extended period of time, there may be an elevated risk of disease transmission, including COVID-19. By signing this form, I acknowledge that I am aware of the risks involved and give consent to receive skin care services from my Aesthetician.

By signing below, I agree to each above statement and release the Aesthetician and the business from any liability for the unintentional exposure or harm due to COVID-19.

Your Aesthetician and all employees of this facility agree that they abide by these same standards and affirm the same. We also affirm that we have updated and expanded our sanitation protocols to more thoroughly fight the spread of COVID-19 and other communicable conditions. New Safety Procedures and Guidelines for Aussie Girl Skin Spa

- A signed copy of the “Precautionary Coronavirus/COVID-19 Liability Release Form” will be required for **all** clients receiving services. If you are under 18 years old, the form will need to be signed by a parent or legal guardian.
NO EXCPTIONS!
- Due to COVID-19 we are temporarily limiting the number of daily appointments to allow appropriate sanitation time between clients. We ask that you respect your appointment time and arrive at least 5 minutes before your schedule time. Late arrivals may need to be rescheduled or can affect the amount of time we have left for your treatment.
- We ask that if you are experiencing a fever, cough, or sore throat, please reschedule your appointment when you are no longer symptomatic. If you have been to a COVID-19 impacted area or have been in close contact with a person infected with COVID-19, we ask that you please reschedule your appointment for 14 days past the date of last contact.
- The 24-hour cancellation policy will be waived for the remainder of 2020. We do ask that if the need arises to cancel your appointment, you do so as soon as possible so we have the opportunity to fill that appointment time. We had previously seen a trend in clients cancelling appointments the night before the scheduled appointment time, this does not allow enough time to fill the appointment slot at such short notice. We understand that emergencies arise and ask for your consideration when cancelling appointments.
- Only those that are scheduled for an esthetic service will be allowed into the office for treatment. Unfortunately, we will not allow friends or family into the office or waiting area until further notice.
- We will be checking temperatures with a no-contact thermometer on all clients entering the office.
- We are requesting that clients wear face masks when they arrive for their appointments and remove them in the treatment room. After the treatment you will be required to wear your mask outside of the treatment room and into the checkout area. The mask protocol is consistent with the CDC’s recommendation to the general public advising them to wear a cloth face covering whenever they must leave their home.
- Hand Sanitizer will be available and required to use before entering the office and provided for use after you have received your treatment, before leaving the treatment room.
- A plastic, non-porous container will be provided in the treatment room for clothing and personal items to store during your treatment.
- Your Aesthetician will be following all health and safety precautionary measures, strict sanitation guidelines recommended by the CDC, DORA, Tri County Health Department for personal health and safety, sanitation in the office and treatment room.

We thank you for your patience and support as we work to have the spa updated and in compliance for reopening. Please feel free to reach out if you have any questions or concerns regarding the above information.
